WHAT'S NEW

The two bridge to culvert replacement projects along the LeRoy Access Road to Highway 6 located at NNE 09-35-19 W2 and NNE 11-35-19 W2 have been completed and a third bridge to culvert replacement project at NE 11-34-21 W2 will begin this summer.

The Ministry of Highways has been contracted to perform line painting on the LeRoy Access Road where the bridge replacements occurred and Twp Rd 342 from Hwy 6 to Rge Rd 2201. Lines should be completed before fall.

BHP will fund the RM to upgrade to primary weight Range Road 2203 from the south boundary of the RM of LeRoy, No. 339 at the intersection of Township Road 340 to the intersection of Range Road 2201 and Township Road 342 (Road 2) and CRF Rejuvenation Fog Seal of Township Road 342 from Range Road 2201 to Highway No. 6 (Road 1). Upgrades are to be completed this year.

Road grinding has begun on Rge Rd 2212/2213 (Sinnett Grid).

Equipment upgrades for this year included a 2024 CAT 150 Grader, 2025 Wester Star Semi, second set of Midland Side Dump Gravel Trailers and a 2023 CAT Loader.

PROPERTY TAX INFORMATION

Property taxes are due on or before Dec 31st. Taxes remaining unpaid after this will be charged 1% penalty per month. When remitting your taxes, please ensure you are paying the appropriate discounted amount and quote your customer number/numbers on your cheques. This number can be found on the top right had corner of the tax notice.

Property tax payments can be made by cheque, cash or electronically. For electronic details please contact your financial institution and contact the RM office for your tax account identification number. When sending a cheque in the mail, please take the delivery time in to account and mail your cheque accordingly. The RM does accept post dated cheques.

PEST AND WEED CONTROL

Tenie Schoettler is appointed Pest Control Officer for the municipality under the authority of *The Pest Control Act*, and will be making inspections in due course. Ratepayers are requested to be diligent in inspection and baiting. Please contact the RM office if Pest Control Services are required.

Bryce Moore is appointed Weed Inspector for the municipality under the authority of *The Weed Control Act*. Please refer concerns about noxious weeds to the RM office for inspection.

RM RIGHT OF WAY

The RM would like to remind landowners that they are liable for any unauthorized work within the right of way. Landowners must obtain permission from the municipality prior to any trenching, digging, tree plating, fence building, etc. within the right of way.

SETBACKS

Did you know the RM has Bylaws providing minimum setbacks of buildings, including dwellings, signs, trees, fences, stone placement, earth or gravel piles, portable structures, dugouts and machinery or other similar objects:

- 45 meters (150 feet) from the centerline of a municipal road allowance, grid road main farm access road; and
- 90 meters (295 feet) within the intersection of the center line is required

On provincial Highways minimum setbacks are regulated by the Ministry of Highways and Infrastructure.

Remember we are here to help! Don't hesitate to reach out to the office to discuss those setbacks or ask if you require a permit in advance of your project. This will help landowners avoid incurring costs that might otherwise be avoided.

ROAD SIGNS

For the safety of yourself and others travelling on our municipal roads, please report any fallen, knocked down or removed road signs to the Administration Office at (306) 286-3261.



RURAL CRIME
